TITLE: RESOLUTION AUTHORIZING THE COMMENCEMENT OF VARIOUS INTERLOCAL SERVICES, IN ACCORDANCE WITH THE STANDARD TERMS OF AN INTERLOCAL SERVICES AGREEMENT BETWEEN THE BOROUGH OF FAIR HAVEN AND THE BOROUGH OF RUMSON

WHEREAS, the Borough of Fair Haven, County of Monmouth, State of New Jersey has determined that it would be beneficial to the Borough to enter into an Interlocal Services Agreement with the Borough of Rumson; and

WHEREAS, the Administrations, with the help of the Department of Public works of both Boroughs have identified a number of areas where working together through Shared Services will result in positive outcomes for both municipalities; and

WHEREAS, the Borough of Fair Haven and the Borough of Rumson have agreed in principal that the Interlocal Services Agreement will include the following services:

- Brush Disposal
- Parks and Grounds Management and Maintenance
- Street Sweeping
- Catch Basin Cleaning
- Engineering Services; and

WHEREAS, it is in the best interest of the Borough of Fair Haven and the Borough of Rumson to begin sharing some of the services listed above, beginning on April 16, 2012, and;


WHEREAS, the Interlocal Services Agreement associated with the services listed above will not be available to be approved by the Governing Body, prior to April 16, 2012;

NOW, THEREFORE, BE IT RESOLVED by the Borough of Fair Haven that Borough Administrator Casagrande is hereby authorized and directed to proceed with any and all required negotiations to finalize the details of an Interlocal Services Agreement, between the Borough of Fair Haven and the Borough of Rumson, for the services listed above.

BE IT FURTHER RESOLVED that the sharing of the services listed above will begin on April 16, 2012 and that the corresponding Interlocal Services Agreement will be finally approved with an effective date of April 16, 2012.

BE IT FURTHER RESOLVED that the Borough Clerk forward a certified true copy of this Resolution to the Rumson Borough Clerk.
